Let me be absolutely clear: this entire situation was
completely avoidable. After I initially offered to
settle for \$50,000, the City chose instead a path of
delay, denial, and deflection. Despite my numerous
emails and repeated attempts to engage with Mayor
Bradley, Joseph LaVeck, Rey Carrion, and others,

my concerns were repeatedly ignored or dismissed without proper consideration. These officials systematically blew me off, refusing to address the issue in good faith.

I repeatedly raised concerns that Mayor Bradley, Joseph LaVeck, Rey Carrion, and others were actively colluding to suppress this issue. The sham investigation led by Mr. Carrion confirmed this, revealing a clear intent to shield misconduct rather than expose it.

Despite numerous warnings that such actions violated ethical obligations and likely breached your oaths of office, those involved persisted in this course. Now, only after incontrovertible evidence of Chief McCann's criminal conduct has surfaced, is the City forced to submit a claim at nine times my original offer—an outcome that could have been avoided altogether.

I will be contacting the insurance carrier directly to ensure they are fully apprised not only of the facts of this case but also of the obstructive and unethical behavior demonstrated by certain officials throughout this process.

Furthermore, I want to highlight that the only Council member who appears exempt from these allegations is Angel Arroyo, who replaced Antonio Baez—an individual who, based on available evidence, was unlawfully occupying office at the time. However, Mr. Arroyo has yet to complete the mandatory Sunshine Law training required by Rule 41 and Ohio state law. This compliance failure is a serious issue that demands immediate rectification.

Given the full scope of these facts, I strongly urge any officials involved in these actions to self-report to the Ohio Ethics Commission. Your conduct constitutes a clear violation of the public trust and your sworn duty to uphold the law. Should you fail to do so promptly, I will proceed with filing the appropriate complaints myself.

This will serve as a formal reminder of the City of Lorain's continuing legal obligations in matters involving insurance claims, civil rights violations, and retaliation allegations.

While I acknowledge that the City may be coordinating with legal counsel or insurers, such coordination does not negate the City's independent obligations under state and federal law. These include, but are not limited to:

- **Timely Reporting & Good-Faith Review:** As you are aware, most municipal insurance policies require prompt notification of claims and good-faith consideration of settlement offers—especially those within policy limits—to protect the insured from excess judgments. Undue delay or categorical denials may constitute bad-faith conduct.
- **Cooperation Obligations:** The City, as the insured, has an ongoing duty to cooperate with its insurance carrier and to evaluate reasonable offers, rather than summarily reject them or disregard documented evidence.
- **Constitutional & Statutory Duties:** My right to petition public officials on matters of public concern—including civil rights violations, whistleblower retaliation, and disability discrimination—is firmly protected under the First Amendment and federal whistleblower statutes. Attempting to insulate public officials from direct accountability through blanket denials or silence does not comport with constitutional norms or public service ethics.
- **Ohio-Specific Statutes:** Under Ohio law, designated officials—such as a Director of Law—may hold settlement authority within certain thresholds. However, refusal to engage or document a legitimate settlement negotiation may raise serious concerns under both public accountability laws and prohibited insurance practices outlined by the Ohio Department of Insurance.

To be clear: I am not asking for a favor. I am documenting an official request for remedy that remains viable but is time-sensitive. If the City believes this matter should be handled exclusively through counsel, I am fully prepared to proceed accordingly, but I will not accept silence, evasion, or procedural deflection as a substitute for substantive response.

Govern yourselves accordingly.

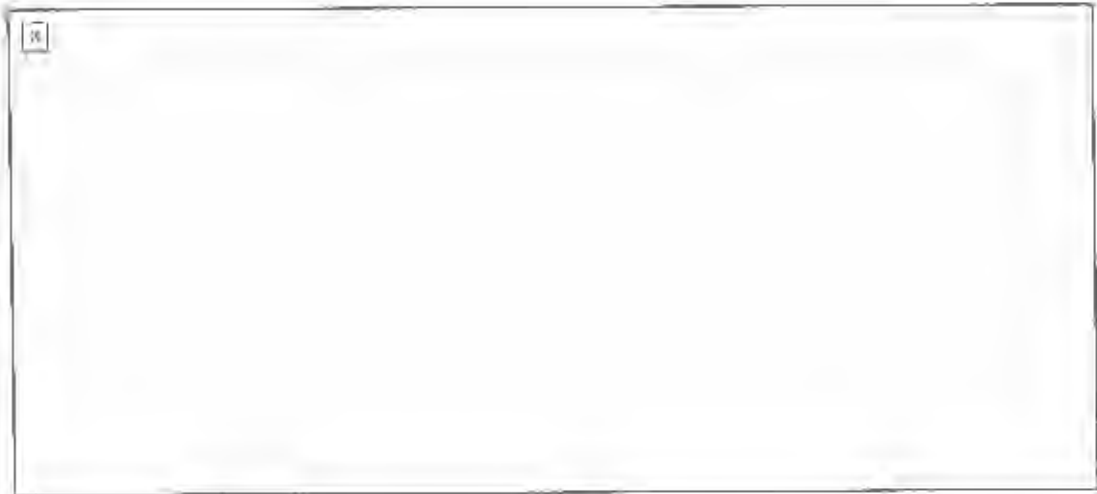

President, Members of Council, and Mayor

My name is Aaron Knapp. I'm a Lorain resident and social worker who has spent considerable time reporting on city policy and technology choices. I'm writing about the proposed \$25,000 Grammarly purchase for the Lorain Police Department reportedly from the Levy Special Revenue Community Service fund. I support clearer writing in government. I also want to make sure we don't trade clarity for compliance risk.

Here is the core issue in plain English. Grammarly is a cloud writing tool. To offer suggestions, it sends the text you type to its own servers for analysis. Police writing often contains Criminal Justice Information—names, dates of birth, witness statements, investigative details, and in some cases NCIC-derived data. That category of information is governed by the FBI's CJIS Security Policy. CJIS is not a brand or a marketing badge, it is a rulebook that dictates where criminal justice data can live, who can touch it, how it is encrypted, how access is logged, how long it is retained, and what rights the agency must have to audit the vendor. If a vendor's systems or personnel can see that data, the city must have a CJIS Security Addendum in the contract and a technical setup that actually enforces those safeguards.

That leads to the first question Council should ask before spending a dollar: Will this purchase be limited to non-CJIS writing, or is it intended for police reports and narratives? If it is limited to non-CJIS work—press releases, recruitment copy, public notices—then say so in a written policy, install it only on non-CJIS machines, and disable any features that train models on our text. If it is intended to touch reports or narratives, then the city must be prepared to produce a CJIS-conformant agreement, show where the data will sit, show that vendor staff are vetted under CJIS rules, and show that the department will be able to audit access and retention. "Secure SaaS" and general certifications are not the same thing as CJIS compliance.

The second consideration is prosecutorial acceptance and courtroom integrity. If report narratives are drafted or polished in a public cloud without CJIS controls, prosecutors may decline to use those narratives, defense attorneys may challenge them, and the city could find itself relitigating the reliability of its own paperwork. Several large departments around the

country have paused or prohibited the use of public, consumer generative tools for this reason while they develop formal policies. Lorain should learn from that caution rather than repeat the lesson.

Third, scope and value matter. Twenty-five thousand dollars is a significant number for a writing assistant. Council should know how many seats are included, which edition is being purchased, how long the term lasts, and which features are enabled. Council should also know whether the tenant will be configured to turn off model training and to minimize or prohibit content retention. Just as important, Council should hear which endpoints will run the software. RMS and CAD machines should not be in scope unless and until a CJIS-conformant agreement and architecture are in place.

There is a responsible path if Council wishes to proceed. Start with a narrow, non-CJ pilot and a short, plain-language policy that defines CJ in terms officers recognize—names, DOBs, case numbers, NCIC hits, and narrative facts from live investigations. Install Grammarly only on administrative workstations, not on systems that touch CJIS networks. Train staff with concrete examples of "what's okay" and "what isn't," and require an attestation that they understand the rule. Set a six-month window to measure whether the tool actually improves non-CJ writing, and commit to making those metrics public. If a single violation occurs—if even one live paragraph slips into the cloud—treat that as a failed control and stop the program while it is still small.

There is also a lower-risk alternative if Council wants to press pause. Lorain already pays for Microsoft Word's editor, which can be used locally and configured not to transmit content to the cloud. A two-page internal style guide—how to structure a narrative, what facts belong where, common phrasing—will improve clarity immediately. Short, focused training on chronology, active voice, and avoiding ambiguity will do more for credibility in court than any algorithm. If leadership still wants AI-assisted drafting for reports, look at tools purpose-built for law enforcement and hosted in government cloud environments with CJIS controls, rather than forcing criminal justice data through a consumer service.

Finally, the funding source deserves a sentence of justification. If this is coming from the Levy Special Revenue Community Service fund, the public deserves to hear why this is the best use of those dollars and what will not be funded as a result. That explanation should be part of the motion, not an afterthought.

Clear writing matters. So does the chain of custody for our data and the credibility of our reports. Please either limit this purchase to non-CJ uses with a written policy and measurable outcomes, or table it until the department can present a CJIS-conformant contract and a deployment plan that protects sensitive information by design.

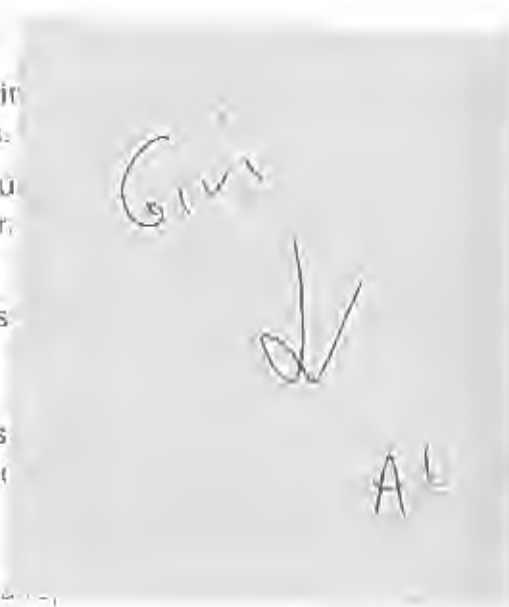

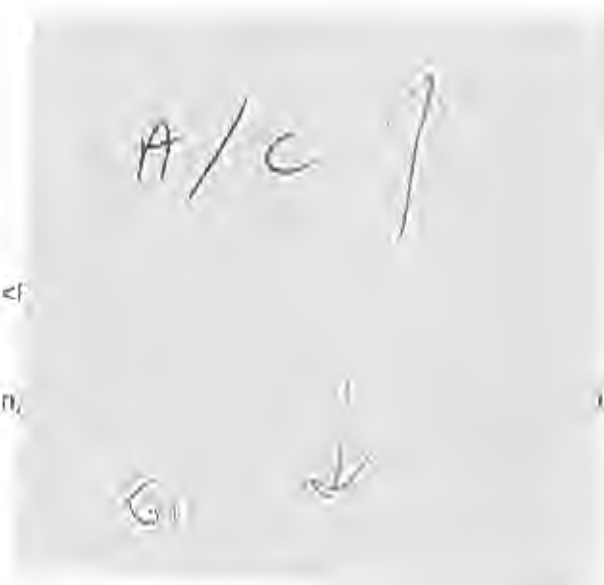

Mayor Bradley and ALL Concerned Parties,

This will serve as a formal reminder of the City of Lorain's continuing legal obligations in matters involving insurance claims, civil rights violations, and retaliation allegations.

While I acknowledge that the City may be coordinating with legal counsel or insurers, such coordination does not negate the City's independent obligations under state and federal law. These include, but are not limited to:

- **Timely Reporting & Good-Faith Review:** As you are aware, most municipal insurance policies require prompt notification of claims and good-faith consideration of settlement offers – especially those within policy limits – to protect the insured from excess judgments. Undue delay or categorical denials may constitute bad-faith conduct.

- **Cooperation Obligations:** The City, as the insured, has an ongoing duty to cooperate with its insurance carrier and to evaluate reasonable offers, rather than summarily reject them or disregard documented evidence.
- **Constitutional & Statutory Duties:** My right to petition public officials on matters of public concern – including civil rights violations, whistleblower retaliation, and disability discrimination—is firmly protected under the First Amendment and federal whistleblower statutes. Attempting to insulate public officials from direct accountability through blanket denials or silence does not comport with constitutional norms or public service ethics.
- **Ohio-Specific Statutes:** Under Ohio law, designated officials—such as a Director of Law—may hold settlement authority within certain thresholds. However, refusal to engage or document a legitimate settlement negotiation may raise serious concerns under both public accountability laws and prohibited insurance practices outlined by the Ohio Department of Insurance.

To be clear: I am not asking for a favor. I am documenting an official request for remedy that remains viable but is time-sensitive. If the City believes this matter should be handled exclusively through counsel, I am fully prepared to proceed accordingly, but I will not accept silence, evasion, or procedural deflection as a substitute for substantive response.

Govern yourselves accordingly.

To the City of Lorain and the Office of the Safety-Service Director:

It has come to my attention – and has been personally confirmed – that individuals, including members of the press, have been denied access to City Hall and its offices without an appointment or for failing to present identification. This includes the recent turning away of a journalist from the Safety-Service Director's office.

Let me be clear: No law – federal, state, or local – requires members of the public to present identification simply to enter a public building or access publicly funded services during regular business hours.

Constitutional Framework

The Fourth Amendment of the United States Constitution protects individuals from unreasonable searches and seizures, including compelled identification without lawful cause. Demanding identification as a condition of entry – absent reasonable suspicion, probable cause, or a legally adopted ordinance – is constitutionally suspect.

The Fourteenth Amendment, through its Equal Protection and Due Process Clauses, guarantees that all citizens have equal access to government services and protections without arbitrary or discriminatory barriers.

Additionally, public buildings such as City Hall are considered limited public forums. Access cannot be denied without:

- A clear, narrowly tailored policy;
- Legitimate governmental interest (such as security);
- Equal and transparent enforcement.

Policies that deny access based on lack of ID or appointment—especially without legal authorization or posted notice—are likely unconstitutional.

Sunshine Laws and Transparency Obligations

Ohio's Sunshine Laws require that public records and public offices remain accessible to the people. Blocking access to government officials or facilities without valid cause violates the spirit and possibly the letter of these statutes (Ohio Revised Code §§ 121.22 and 149.43).

Notice of Audit

As such, I—alongside other members of the public and press—will be conducting independent audits of the City of Lorain's entry policies and procedures to ensure that:

- No unconstitutional identification or appointment requirements are being enforced;
- No public services are being unlawfully withheld from individuals without ID;
- No retaliation is directed toward those exercising constitutional rights, including First Amendment-protected recording of public officials.

These audits are peaceful, lawful, and protected activity. Any effort to interfere with or suppress them could lead to civil liability under 42 U.S.C. § 1983 for deprivation of rights under color of law.

Requested Action

I am requesting, in writing:

1. A copy of the City's written policy (if one exists) that authorizes requiring ID or appointments for public access;
2. Clarification as to whether such a policy was lawfully adopted by ordinance, or implemented without public input;
3. Immediate cessation of any unconstitutional restrictions to public access, and assurance that press and civilians will not be denied entry or retaliated against.

I appreciate your prompt attention to this matter and trust you will act in accordance with your oath to uphold the Constitution.
