Dear Lorain City Council Members and Councilman Angel Arroyo,

I am writing to formally file a complaint regarding Councilmember Mary Springowski and a serious breach of confidentiality involving my private communications.

It has come to my attention, as documented in a police report, that Councilmember Springowski shared emails I sent to her and other government officials with Tia

Hilton, who had a temporary protection order (TPO) against me. I understand that this TPO was later allegedly used to claim that I violated the order. Sharing my private communications with someone legally barred from contacting me, and then allowing or facilitating the use of that information to allege violations against me, is deeply concerning, unprofessional, and may constitute retaliation and misuse of power.
